

## Registration for Online Services

Follow this link <https://lic.ok.gov/PublicPortal/OREC/index.jsp> to access Oklahoma Real Estate Commission Online Services.

To register, click the “Login” link on the left-hand border. **Do NOT select “First Time Applicant”!** In the section “Enroll in Online Services” to the right, enter your **PIN Number, First Name and Last Name** as it they appear in your registration e-mail. Also, enter your Email address where indicated and select a password (enter it in the two boxes indicated). Click “SUBMIT” button.

The message “This Email Address has now been registered in the Online Service” will indicate success. Back on the Login screen, proceed to the “Returning User” section toward the middle of the page. Enter your Email address and password. After clicking “Login,” you will be on the “My Services” screen. Please take a moment and select “My Profile” on the left-hand border. Complete the Password Reminder Question and Answer, which will enable you to access Online Services if you forget your password. Also, please input or update your personal address and phone(s) on this page.

Be aware that the password you use here will affect other online licenses you may already have with the State of Oklahoma – such as Nursing Home Administrator or Certified Public Accountant. If you already have a password with one of those agencies, you can try it on the login page without following the above steps.
